Definitions

1. In these Regulations—

"Act" means the Limited Liability Company Act;

"\$" means the unit of currency of the United States of America.

Words in company names requiring approval

2. The words and expressions set out in Schedule 1 are prescribed as words and expressions that require the approval of the Registrar before they can be used in the name of an international business company.

Forms

- **3.** (1) The forms set out in Schedule 2 are prescribed for use in the matters under the Act to which they relate.
- (2) The form set out in Schedule 3 is prescribed for use in relation to section 18 of Part 1 of Schedule 4.

Fees

- **4.** (1) The fee required to be paid under the Act for a filing or other service set out in Column 1 of Part 1 of Schedule 4 is the amount set out opposite—
 - (a) in Column 2 if the filing or other service is done other than electronically; and
 - (b) in Column 3 if the filing or other service is done electronically.
 - (2) A penalty is payable in the amount and in the circumstances set out in Part 2 of Schedule 4.

PENALTIES

Annual licence fee paid after due date

1. An LLC that fails to pay the annual licence fee under section 18 of Part 1 of this Schedule by the anniversary date shall, in addition to the licence fee, pay a penalty of an amount equal to 10% of the annual licence fee.

Annual licence fee paid 3 months late

2. An LLC that fails to pay the annual licence fee and the penalty due under section 1 of this Schedule before the expiration of 3 months from the anniversary date shall, in addition to the annual licence fee, be liable to pay a penalty of an amount equal to 50% of the annual licence fee.
